ARTICLE 200 - The Active, Emeriti and Honorary Members of the Supreme Council accredited to each State; the Past First and Past Second Lieutenant Commanders of the Council of Deliberation; the Past Commanders-in-Chief of Consistories; the Past Most Wise Masters of Chapters of Rose Croix; the Past Sovereign Princes of Councils of Princes of Jerusalem; the Past Thrice Potent Masters of Lodges of Perfection; those members of Subordinate Bodies in the State who have received the Meritorious Service Award from the Council of Deliberation of such State, and the first three elected officers as well as the Treasurer and the Secretary of Subordinate Bodies, shall constitute a Council of Deliberation for that State of which the Deputy for that State shall be ex officio Illustrious Commander-in-Chief.

ARTICLE 329 - The first three officers as well as the Treasurer and the Secretary of each Subordinate Body shall be elected. All other officers shall be elected, or appointed by the presiding officer of the Body as the Rules and Regulations of the Body provide.

PROXIES

ARTICLE 201 - Any Officer of a Subordinate Body of the Rite who is entitled to a seat in the Council of Deliberation for his State, but is unable to be present at any session of such Council, may appoint as his proxy, to act in his stead, any member of such Subordinate Body, provided, however, that such proxy shall not represent more than one member of such Council.







I wish to express my gratitude to all who took time out of their busy schedules to be here today. Let me extend a warm welcome to our distinguished guests. I hope you find our hospitality accommodating and the session informative and enjoyable.

I wish to extend my appreciation for those officers, committee chairs, and committee members who worked throughout the year for the betterment of the Scottish Rite of Connecticut. And finally, let me express a very special thank-you to the Valley of Waterbury for hosting this session.

NECROLOGY

Masonry teaches us to live our life in a manner acceptable to God so that when that day comes when we lay down our working tools of this mortal life, we may be welcomed into the Kingdom of our Lord. This past year, fourteen members of this Council of Deliberation have completed that journey from which no traveler returns. They are:

Illustrious Brother Warren J. Blessing, 33°, from the Valley of Hartford. Illustrious Brother Blessing was an outstanding Freemason who had a profound influence on the Scottish Rite He was coroneted a Sovereigh Grand Inspector General on August 29, 1982

Illustrious Brother Howard R. Clark, 33°, of the Valley of Bridgeport. Illustrious Brother Clark was coroneted an Honorary Member of the Supreme Council on September 27, 1994.

Illustrious Brother Winston S. Dean, MSA, 33°, of the Valley of Norwich. A hardworking Freemason, Illustrious Brother Dean served the Van Rensselaer Council, Princes of Jerusalem as Sovereign Prince and the Norwich Chapter of Rose Croix as Most Wise Master. He was a recipient of the Arthur M. Brown Meritorious Service Award in 2005 and was coroneted a Sovereign Grand Inspector General on August 31, 2010.

Illustrious Brother Richard W. Graves, **33**°, of the Valley of Hartford. Illustrious Brother Richard served the Cyrus Goodell Chapter of Rose Croix as Most Wise Master and was coroneted a Sovereign Grand Inspector General on September 24, 1986.

Illustrious Brother Alexander Horochivsky, MSA 33°, of the Valley of Norwich. A regular attendee of this Council of Deliberation, Illustrious Brother Alexander received his red cap and jewel in 1981 and became an honorary member of the Supreme Council on August 31, 1987.

Illustrious Donald C. Murray, MSA, 33°, of the Valley of New Haven. Illustrious Brother Murray served the E.G. Storer Lodge of Perfection as Thrice Potent Master in 1995 and the New Haven Chapter of Rose Croix as Most Wise Master in 1984. He was awarded his MSA on June 13, 1986 and was coroneted a Sovereign Grand Inspector General on August 27, 1996.

Illustrious Brother Franklin I. Smith, MSA, 33°, of the Valley of Waterbury. Illustrious Brother Smith may be best remembered for his colorful pastel suits. He was a dedicated Freemason who served the Doric Lodge of Perfection as Thrice Potent Master and as his Valley a director of the Waterbury Masonic Temple Corporation, where he played an instrumental role in the acquisition and renovation of the Valley's current home. He was awarded his MSA on June 10, 1977 and was coroneted an Honorary member of the Supreme Council on September 26, 1984.

Brother William G. Bryce, MSA, 32°, of the Valley of Hartford. Brother Bryce served the Hartford Council, Princes of Jerusalem as Sovereign Prince and and received the Arthur M. Brown Meritorious Award

on June 14, 1991.

Brother Donald H. King, MSA of the Valley of Bridgeport. Brother King was awarded the Arthur M. Brown Meritorious Service Award on June 19, 2009.

Brother Alexander K. McDonald, MSA, 32°, of the Valley of Hartford. Brother McDonald served the Charter Oak Lodge of Perfection as Thrice Potent Master and was awarded his red cap and jewel on June 12, 1987.

Brother Karl H. Sjovall, MSA, of the Valley of Norwich. Brother Karl was awarded the Arthur M. Brown Meritorious Service Award on June 10, 1994.

Brother Reginald Abbott, 32°, of the Valley of Hartford. Brother Abbott had served the Charter Oak Lodge of Perfection as its Thrice Potent Master.

Brother Joseph P Fagen, **32**°, of the Valley of New Haven. Brother Fagen served the New Haven Chapter of Rose Croix as its Most Wise Master on 1997.

Brother Francis E. Rebmann, 32°, of the Valley of Norwich. A dedicated Scottish Rite Freemason, Brother Rebmann was serving the Valley as Secretary up until the time of his death.

Each and every one of us plays a role in granting our departed brethren immortality when we live our lives as they lived theirs, when we recall the influences they have had on us and when we share our fond memories of them with others. Let us close our eyes and recall a fond memory of these brothers as our Prior, the Illustrious Brother Gerald P. Thompson leads us in a moment of prayer.

STATE OF THE RITE

The Committee on the State of the Rite has presented their report and I thank them for their efforts. The Scottish Rite remains strong in Connecticut. Our Valleys are financially stable and we are seeing signs that declines in our membership may be ready to rebound. The Supreme Council has given Valleys increased autonomy relative to Valley organizational structures and degree schedules and I am pleased that Connecticut Valleys are beginning to utilize the flexibility afforded by these changes. While these changes provide flexibility, they do come with an added burden. Valley leaders now have the additional responsibility of identifying officer structures and degree schedules that best serve their Valleys. This requires careful thought and planning. Valleys who adopt consolidated officer structures must ensure that the work to be done is reallocated and that we do not disengage our members. The geography of Connecticut and close proximity of our Valleys provides us an opportunity to provide a greater selection of degrees each year to our membership. Through increased inter-valley communication and cooperation, I am certain we will maximize the advantages that these changes provide for the betterment of Connecticut Scottish Rite.

CHARITABLE WORK

I am in support of the recent move to direct attention and efforts to the Benevolent fund to provide assistance to brethren in need. However, we all should continue to be very proud of our registered charities. The Children's Dyslexia Center of Connecticut continues to be an overwhelming success. You will hear our Center Director, Cheryl Sharkis, and our Board of Governors chairperson, Illustrious Brother Charles W. Yohe, 33°, attest to our clinical success and the efficiency of our operation. I am so proud of the support this Center

receives from across our state. It is because of your efforts the Center has become the Children's Dyslexia Center of Connecticut. I assure you those who benefit from the work done at the Center are well aware of our Fraternity. Students at the Center have served as leaders in DeMolay and we have had students and fathers join Blue Lodges. We saw changes made in our Abbott scholarships program this year which greatly reduced the number of eligible candidates for the scholarship. Once again, you stepped up to the challenge and the Valleys picked up the slack. You will hear shortly the report of our Scholarship Committee by Illustrious Brother Thomas M. Maxwell, 33°. You should all be very proud of the impact you have made on the academic lives of so many of our young people. Let me take a moment to recognize the exemplary work of Illustrious Brother Maxwell. He has served as this Council's Scholarship chairperson for many years. The system he has put into place, coupled with his talents and passion to serve, have resulted in a Scholarship program who is efficient, equitable and certainly best-in-class. Illustrious Brother Tom, on behalf of out your Scottish Rite brethren and the hundreds of children that havebenefited from your efforts, we thank-you and promise our full support as you continue to advance in the Grand Lodge line. Finally, let us not forget our Museum and Library. Maybe not as popular as the Learning Centers, our Museum and Library is a world class institution and serves a vital function in maintaining the history of our Scottish Rite. Connecticut Freemasons should be extremely proud that when the challenges mounted, the Supreme Council turned to Connecticut's own Illustrious Brother Richard V. Travis, 33° to lead the museum down a new path and realign the Museum and Library with the current funding paradigm. Please remember the Museum and Library when making your charitable donations and join me in congratulating Illustrious Brother Travis for a job well done.

CONCLUSION

If I learned anything in my first year as your Deputy, it is that Connecticut Scottish Rite can be characterized as having a deep passion for the tradition, rituals, and tenents of the Scottish Rite. We must be careful not to let that passion for tradition impede necessary change. My brothers, change is never easy - it takes us out of our comfort zone. This year we have witnessed what can happen when change is not effectively communicated and explained. Going forward we must work together to do a better job building the case for change, identifying all who will be affected and addressing all concerned. We must pay attention to both the emotional and tactical aspects of implementation. Toward that aim, I will continue to schedule an informational meeting after each Supreme Council session and I will make myself available to all Valleys to meet with your Executive Committes, officer corps, and membership. We are all familiar with our Sovereign Grand Commander's concerns over declining membership. The hard truth is if we do not reverse the trend of the last two decades, I may be the last, or next to the last Deputy for the State of Connecticut. Brothers, I love this fraternity too much to ever allow that to happen and I believe you feel the same way. My primary objective is to make sure we work together to sustain and then grow our Rite.

We must identify the issues that are impacting us and develop and deploy effective countermeasures. These include ensuring we have ready successors for key officers, placing a renewed focus on the needs of all our brethren. We must proactively support of our Blue Lodges as they are our only source of new members. We must honestly assess ourselves and put together a strategic plan that addresses our weaknesses by taking full advantage of our strengths. There is much work on our trestle board and I am confident that collectively we have the talent and desire to accomplish it.

In closing, let me express my sincere appreciation to Illustrious Brothers A. Norman Johnson, Richard Travis and James Spencer. They are an incredible source of inspiration and guidance and I could not even imagine continuing in this position without their help. A special thank-you goes out to our newest Active, Illustrious Brother Bruce Work. He likes to joke about his being "Inactive." I assure you there is nothing further from the truth. I am truly fortunate to have someone of his experience, talent, and dedication by my side. Finally, let me offer my gratitude to all my Connecticut Scottish Rite brothers for their support and candor. I consider myself blessed to be given the opportunity to serve such an honorable group of men.

REPORT OF THE ACTIVE

To the Illustrious Commander-in-Chief, officers, and brethren of the Connecticut Council of Deliberation in session at Ansonia, Connecticut on June 15, 2012:

It was a great honor and distinct personal privilege to have been elected and crowned an Active Member of the Northern Masonic Jurisdiction A.A.S.R. for the State of Connecticut in Chicago, Illinois on August 30, 2011. I feel tremendously blessed and very grateful for the opportunity to serve an organization I believe in and deeply respect and I can assure you it was a day that I will never forget.

It has been a pleasure to work with our Deputy, Ill. David L. Sharkis, 33°, who displays great devotion to our Craft through his efforts not only in Supreme Council, a position of much responsibility, but also in his active participation on a local level throughout our state.

During this year, I have had the opportunity to visit all Valleys and Consistories and represent our Deputy at Scottish Rite, York Rite, and Prince Hall functions when his schedule prevented him from being in attendance. I appreciate the warm and fraternal greetings both I, and when appropriate, my wife Ann, have received on these several occasions.

My brothers, we have an unexplainable dichotomy in our state, which I would ask each and every one of us to consider. My observation is that portrayal of degrees is getting better and better each and every time we present them. However, our attendance, for the most part, is getting worse.

I would suggest that we look at the difference between **leadership** and **management** within our Fraternity, especially when we look to appoint brothers to our officer lines. Peter Drucker, the father of modern management, wrote; "**Management** is doing things right," "**Leadership** is doing the right things." We have done a great job of <u>managing</u> our degree work and our casts, both on-stage as well as back-stage, but have we been leaders or are we just going along for the ride, looking for another cap or jewel?

Leadership is the "people side" of the job. Are we getting so caught up in the management of our work, that we've forgotten why we are here...to take good men and make them Better. We need to ask ourselves, as a new candidate sitting here witnessing the degrees of Scottish Rite Masonry might ask, "Where are the Members?" "Where are the Officer's I met at the last Degree?" Would we invite a guest to our home only to have him show up and our family not be there? Do we not owe it to our fellow Scottish Rite Brethren to support their on-stage degree portrayals, as well as supporting our new candidates? Are we attending Executive Council meetings to assist our Leaders with a positive outlook, in making our Valley's better, by creating a picture of the desired future and helping direct any changes? Have we done our best to communicate the future and strategies to our Brethren, and encouraged their participation?

My Brothers, **Leadership** is not a "sometimes thing", it's an "all the time thing!" **Leadership** is not just telling them things...**Leadership** is showing them by example. Proposal #1 – To amend ARTICLE IV, Sec. 6:

From: "The Committee on Meritorious Service Award shall consist of five members of the Supreme Council, one from each of the five Valleys in the state. It shall be the duty of this committee to receive and consider the nominations from the various Valleys and to make recommendations to this Council, at each annual meeting thereof, of members of the Rite in this state to receive the Meritorious Award."

To: "The Committee on Meritorious Service Award shall consist of the Presiding Officers of the Bodies of the Rite in the state who shall present recommendations in writing through the Chairman of the Committee to the Commander-in-Chief prior to each Council of Deliberation."

Valleys that do not own buildings receive the coverage at no cost. Valleys that own buildings are invoiced a nominal fee based upon their increased exposure. Valleys are also provided the option of obtaining additional expanded liability as well as property, boiler and machinery, inland marine, auto, and workers compensation.

Under this master insurance program, all Valleys are assured that they will have access to the coverage limits they need to protect their assets, and have access to lower premiums than under individual policy arrangements.

REPORT OF THE COMMITTEE ON SCHOLARSHIPS

To the Illustrious Commander-in-Chief, officers, and brethren of the Connecticut Council of Deliberation in session at Ansonia, Connecticut on June 15, 2012:

This year, the Supreme Council, located in Lexington, Massachusetts has awarded \$10,900.00 to Connecticut for Abbott Scholarships. The Scholarship Committee of the Connecticut Council of Deliberation has recommended 11 applicants to become 2012 Abbott Scholarship recipients. These recommendations were made to Illustrious David L. Sharkis, 33°, Deputy for Connecticut and to the Supreme Council.

Named for Leon M. Abbott, Sovereign Grand Commander from 1921 to 1932, the scholarship program provides financial support for the continuing education of young men and women from Scottish Rite families and Masonic-related youth groups. Since 1951, more than \$3 million has been awarded to students from each state of the Northern Jurisdiction.

Eligibility: Those meeting any of the following criteria are eligible to apply for the 2012 Abbott Scholarship program:

• A Scottish Rite Mason of the Northern Masonic Jurisdiction.

• A child of a Scottish Rite Mason of the Northern Masonic Jurisdiction who is a high school senior or currently enrolled at an accredited college or university, who has attained a minimum grade point average of 2.75 on a 4.0 scale.

• A member of DeMolay, Rainbow or Jobs Daughters in the Northern

Masonic Jurisdiction who is a high school senior or currently enrolled at an accredited college or university, who has attained a minimum grade point average of 2.75 on a 4.0 scale.

The State Scholarship Committee received a total of 11 applications from the five Valleys in Connecticut. The 11 recipients of this year's scholarships demonstrated excellent scholarship and genuine financial need. Impressive letters of recommendations from teachers, professors, and academic counselors supported all applications. Recipients also exhibited extensive volunteer community service, broad extracurricular activities, and leadership and honors/ awards in sports, music, and drama. Some are holding part-time jobs during the school calendar year and full-time summer employment to help pay for college costs.

Again, this year, all five Valleys in Connecticut have given their own college scholarships. The Valley of Bridgeport has given five scholarships, the Valley of Hartford has given sixteen scholarships, the Valley of New Haven has given nine scholarships, the Valley of Norwich has given one scholarship, and the Valley of Waterbury has given two scholarships. Collectively, our five Valleys have awarded a total of 33 scholarships.

REPORT OF THE MEMBERSHIP AND RETENTION COMMITTEE FOR THE STATE OF CONNECTICUT

To the Illustrious Commander-in-Chief, officers, and brethren of the Connecticut Council of Deliberation in session at Ansonia, Connecticut on June 15, 2012:

The chairman of the State Membership and Retention Committee respectfully submits the following report for the year 2011 - 2012.

In October of 2011, our Deputy held a meeting in New Haven. Part of this meeting involved giving tasks to the various state wide committees. The Membership and Retention committee was charged to come up with a plan to implement the Book End concept in Connecticut, find a way to establish a better relationship with our Grand Lodge, discuss the possibility of having all state family life events, to see if there is any interest in having a life member AASR program, and assist in the planning for a gathering for 2014 in absence of a Supreme Council meeting.

I sent out several power points on the Book End concept as well as other membership presentations to the chairs of each valley, attempted to schedule a meeting, and then got sent to California several times, pretty much obliterating any chance of making the meetings I would schedule.

I will say here and now that it is the intent of this committee in 2012 and 2013 to have quarterly meetings with representatives of each Valley who are empowered by their Executive Councils to make decisions and agreements on behalf of their Valleys. This authority is critical if we are to properly implement the Book End concept as well as some other membership incentives, coordination of family life events, and planning for our 2014 meeting.

I'll address plans to meet and finalize these goals and some thoughts I would ask you to keep in mind, but I would like to cut to statistics for your consideration

In 2012 we made 48 Scottish Rite brothers and happily restored 11, for a total of 59, in comparison with the roughly 400 brothers who were raised last year in our blue lodges. Given our agreement that we wait a year before asking a newly raised blue lodge brother to consider the AASR, I am hoping we see growth of a lot more than 59. We lost 133 due to death, 87 due to suspensions, and 12 due to dimits, for a total loss of 232. Brothers, we started the year with 3,059 and currently stand at 2,886 Scottish Rite brothers in Connecticut, which put us below 3,000 for the first time. Recent decisions by the Supreme Council now give us far more freedom to decide what our Valleys will do. We are in control of our own destiny far more than we ever have before and we need to use this empowerment to find ways to continue to recruit and keep our brothers interested. The Book End concept – as most of you know, this concept requires the 4th degree and the 32nd degree, with 3 other degrees put in. There is no longer a requirement to have 3 lodge, one council, one chapter, and 3 consistory degrees. The challenge is to make sure that we do not take an easy way out and have less meetings but decide, are 5 degrees enough? Which ones do we do? Should we have another night for discussion, enlightenment, or a mixer with our ladies?

Some Valleys will continue to use the 8 degree schedule because they have implemented a successful model. Other Valleys may want to use the bookend concept in an attempt to be more successful. The challenge for the statewide membership committee is to make sure we don't do five of the same degrees in the same session to the detriment of doing different degrees. Doing this kind of plan with five different executive councils and different minds requires regular meetings, updates, and coordination. This is why I pointed out that your membership chair needs to be able to speak for your Valley in regards to degree planning and coordination.

We have a concept in mind to start better relations with our Grand Lodge. I hesitate to discuss it until we have buy off from all the Valleys, but rest assured, if implemented, it should give dividends both to Grand Lodge and to your Valley.

We found that there are duplicated Family Life events throughout our state. A quick example is the Valley of New Haven sponsoring a trip to the New Britain Rockcats with the Valley of Hartford doing the same thing a week or two later. The challenge again is to see if Valleys could save some money and realize a greater turnout if something of this nature could be coordinated in the future.

We are looking into what it would take to have a lifetime Scottish Rite membership. There are lots of actuarial tables that we are looking at. Certainly from a membership standpoint we would really prefer that no one pass away, but it does present a challenge and it is being considered.

Finally, regarding assisting with planning a gathering for our 2014 meeting. It has become apparent that a committee needs to be convened for this purpose only. I think that members of the statewide membership committee may be part of this but the feeling is that this committee needs to have a pure focus and I would make a motion that this special committee be created.

In closing, we have some work to do and it requires more coordination and group effort than ever before. We can no longer be 5 different fieldoms operating separately in a loose confederation. We are going to have to unite and in some cases, change what a valley is doing for the benefit of the entire state. We basically either become successful together or dwindle away to nothing separately. Your choice, your right, but also your legacy. What would you like it to be?

REPORT OF THE COMMITTEE ON THE STATE OF THE RITE

To the Illustrious Commander-in-Chief, officers, and brethren of the Connecticut Council of Deliberation in session at Ansonia, Connecticut on June 15, 2012.

The 2011-2012 Scottish Rite year demonstrated continuing and expanding cooperation between our Valleys, greater efforts to attract new members, and more opportunities to join and work with our brethren of Prince Hall.

Supreme Council

Three brothers of the Rite in Connecticut were coroneted with the Thirty-Third Degree and were created Sovereign Grand Inspectors General and Honorary Members of the Supreme Council at the Supreme Council Session in Chicago, Illinois during the August 2011 Supreme Council session:, Kenneth A. Barrett and Jeffrey A. Flynn of the Valley of Hartford, and James Louis Vander Eyk of the Valley of Waterbury. This year Connecticut has six candidates. Our 2012 class consists of Carl A. Anderson and Robert A. Simon, MSA of the Valley of Hartford, Ernest Dubois of the Valley of New Haven, Craig McClelland of the Valley of Bridgeport, Richard Frazier, MSA, of the Valley of Waterbury, and William Breed of the Valley of Norwich.

Membership

The great tide of men who flooded our membership roles after returning victorious from the Second World War is now well into its ebb as those brothers continue to answer the call of the Grand Architect and lay down the working tools of life. This mortality is a dagger at the heart of Freemasonry and especially the Scottish Rite.

Forty percent of our membership is over 75 years of age, and fewer than Thirty percent of Blue Lodge members are Scottish Rite members.

The Ambassador Program has been established and implemented, and ambassadors have been appointed. Their presence helps establish recognition of Scottish Rite in the Blue Lodges and leads to new members. Scottish Rite Masons are working to help Blue Lodges attract good men. Our lodges have had noticeable increases in interest, most of it from young men who have found us on the internet. Society is changing and it is necessary to communicate with these young men using their means of communication, Facebook, Twitter, and other Internet social programs.

Scottish Rite in Connecticut continues to benefit from the Supreme Council web site, the Connecticut Council of Deliberation web site, and the web sites of all our Valleys. The Connecticut sites have been up for approximately 3 years and continue to be superbly managed by Ill. Francis G. Way, MSA, 33°. Under III. Brother Frank's management, our sites are offering the information, functionality, and connectivity we all need. It is clear they are being used and as a result we are receiving increased petitions for membership. The Valley of Hartford estimates that they are seeing an approximately 50% participation

rate of new Sublime Princes of the Royal Secret in the degrees.

We urge all Valleys to take advantage of the Membership and Leadership Seminars offered by the Supreme Council. Members of all Valleys attended the Membership and Leadership Seminars this year. They were excellent, surprisingly even better than last year, and allowed for not only the exchange of ideas but cemented fraternal bonds and friendships forged beyond state lines throughout the jurisdiction.

Some of the Valleys are having difficulty in filling all of the officer positions. The Valley of Norwich is experimenting with a modified version of the Green Bay Model. This model allows three elected officers in the Lodge, Council and Chapter. These officers will be responsible for all activities and may not necessarily progress up the line. The results of this experiment will be reported next year. The Valley of Waterbury has adopted a model that has two officers in the Lodge, Council, and Chapter for two year terms. The officers are expected to progress upward at the end of the two years. To date, this has been very successful.

My brothers, this is a new age. In the past, Valleys traveled as Valleys, today individual Scottish Rite Masons are able to find the degrees they need to fill their Passports and are traveling by themselves or in small groups to accomplish that goal.

Children's Dyslexia Center of Connecticut

Our Children's Dyslexia Center of Connecticut in Waterbury is continuing to assist young people to overcome dyslexia. The center continues to operate at capacity with a significant waiting list.

Our Deputy, Ill. David L. Sharkis, 33°, the Connecticut Active Members, and our Chairman, ILL. Charles W. Yohe, are working to strengthen the Children's Dyslexia Center of Connecticut Board of Governors and to broaden its membership to include men and women from outside our fraternity and to increase its ability to fundraise locally.

Last year, the Valley of Hartford again sponsored a 5K run/walk for Dyslexia that had over 120 participants. The Valley of Waterbury sponsored the Walk for Dyslexia with over 400 participants and raised about \$8,500. The Valley of Norwich donated \$5,000 earned from selling clam fritters and chowder at the North Stonington Fair. These efforts are to be congratulated, but more is needed. Please support our Dyslexia Center whenever and however you can. Anything you can do will be worth the effort.

Masonic Youth

The Valleys continue to support the Order of DeMolay and the Order of Rainbow for Girls, both financially and with donations of time. This year 27 Valley Scholarships, among all the Valleys, were given, as well as 11 Abbott Scholarships. These young people are not only our hope for the future, but also the hope of society in the years to come. They continue to merit our support and encouragement.

Valley Activities

Connecticut Consistory, Lafayette Consistory and Nathan Hale Consistory, with the Valleys of the Connecticut Council of Deliberation have conferred all of the necessary degrees. In addition, the Valley of Norwich portrayed the new 19°, and the Valley of Hartford portrayed the proposed new 32 degree.

Brothers from all of the Valleys regularly visited and participated in the other Valley's degree portrayals and Family Life programs. The Valley of Norwich on several occasions had degree participation from members of the United Supreme Council, Northern Jurisdiction, United States of America, Inc. Scottish Rite Masonry, Prince Hall Affiliates. The Valley of Norwich has also been cementing fraternal relations with the Valley of Providence, RI. Several brothers make regular journeys between the Valleys to continue their Masonic education and enjoy the fellowship.

Family Life programs continue to flourish in our Valleys in support of the Sovereign Grand Commander's ICE program. Our Valleys have sponsored trips to the New Britain Rock Cats, Connecticut Sun basketball games, UConn football and women's basketball games and the Goodspeed Opera House. Summer picnics, family dinners, 32° graduation dinners, the Players Club of Norwich, and the workers' night dinner in Hartford, the Abbott Scholarship program, the Walk for Dyslexia, and the 5K run/walk fundraiser continue to be favorites in our Valleys. This summer, the Valley of Waterbury has scheduled the New Britain Rock Cats baseball game for July 13th and a picnic for August 11th, the Valley of Bridgeport has scheduled the Connecticut Sun basketball game for August 18, and the Valley of Hartford has scheduled the 5K Run/Walk for Dyslexia for July 28th. The Valley of Hartford has also scheduled trips to the Metropolitan Museum and the Cloisters in New York. The Valley of New Haven has scheduled a summer picnic for July 21, a clam bake for June 23, and a wine tasting for September 29.

Conclusion

All the Valleys in the Connecticut Council of Deliberation are working hard; diligently trying to include their families in programs and to reach out to their communities. Much has been done. Much has been accomplished, but more is needed if we are to succeed in stabilizing and increasing our membership. We need to continue to find the leaders in our fraternity and give them the education they need to help us grow.

We have the skilled brothers to do the work. We have the support of our statewide leadership and the Supreme Council. And, we have the best message; toleration, understanding, brotherly love, truth, and most importantly fraternity.

STRATEGIC PLAN FOR THE STATE OF CONNECTICUT

Connecticut AASR Strategic Plan

To the Illustrious Commander-in-Chief, officers, and brethren of the Connecticut Council of Deliberation in session at Ansonia, Connecticut on June 15, 2012:

The Strategic Planning Committee has been directed this year to become more involved in the direction and goals for the Scottish Rite in Connecticut. The idea is to focus the Rite onto one strategic plan for the state that will allow for greater collaboration and leadership development in the Valleys and Consistories. The plan will incorporate the vision and goals of the Supreme Council's State of the Rite/Strategic Planning Committee from their 2011 report (2011 Proceedings, pg. 226-229). The vision is "We will strive to be a fraternity that fulfills our Masonic obligations to care for our members". The stated mission to achieve this is as follows:

Provide Inspiration for our members through meaningful programs and degrees. Provide Convenient opportunities for our members to enhance their lives. Provide Enjoyable programs and fellowship activities for our members."

The Strategic Planning committee has been asked to come up with steps to achieve the goals, noting the obstacles that could potentially be in the way. Our aims are to leverage the organization to increase collaboration, instill ownership to improve accountability, and to help in identifying and encouraging leaders for our Valleys and Consistories. As has been noted in our previous reports to the Council, our valleys are working well with the ICE concept and all Valleys are providing their members and families with beneficial programs, but more can be done from a state-wide perspective, especially with our 200th Anniversary celebration underway. A number of recommendations are made at the conclusion of this report.

The main goal for this upcoming year is to begin the process of streamlining the strategic planning in the state and to work towards a state plan that all Valleys can subscribe to. The aim is to bring the state plan in line with the Supreme Council's plan using our Council mission statement as a basis. This would in no way stop the individual valleys from setting their local goals as before, but more to ensure that we are all on the same page. The size of our state lends itself naturally to easier communication and collaboration on degrees and fellowship activities and with the new "book end" degree requirements (4^o and 32^o with three additional degrees) moving along, increased cooperation with scheduling and degree choices is needed. This will also hopefully increase visitation between Valleys, bringing us closer together. One of the greatest strengths of the Scottish Rite is the ability to bring together brothers from the

different lodges in our Valleys and we should actively encourage seeing degrees in all our Valleys. It was interesting to note how lightly attended in April the portrayal of the proposed new 32nd degree was in the Valley of Hartford. If we are as interested in the development of our degrees as has been said, the auditorium should have been at near capacity. As we know attendance has been light for many of our degrees and increased collaboration and communication between the Valleys should help this. Part of the recommendations will deal with proposals on how we can increase communication.

We will also look at what obstacles lie ahead for us as we move forward. The Supreme Council committee listed a number of these, from financial concerns, lack of flexibility, and communication failures, to the "competition," for they are here in our state and then address them confidently and quickly.

In conclusion, our Valleys are strong and we are seeing a slow increase of new members. Though we may not always be able to outweigh the losses, we will continue to increase in new membership, especially with the movie version of "The Lost Symbol" potentially coming out in the midst of our 200th Anniversary next year (the movie is listed as being in the definite pre-production stage with the script being finalized). Since the Scottish Rite will no doubt be a major factor in the movie, we need to be prepared to take advantage of it as a state. Those who were able to hear III. Brother Chris Hodapp's paper "The Dan Brown Effect on Freemasonry," at Masonic Lodge of Research, will attest to this. Our future is in our hands and no one elses, so it behooves us to continue to increase the strength of our fraternal bonds as Scottish Rite Freemasons.

Recommendations:

That the Council of Deliberation Strategic Plan be modified and adopted as a state-wide strategic plan, incorporating the Supreme Council's State of the Rite/Strategic Planning Committee's mission and vision for the Scottish Rite (draft being developed).

That state-wide plans be started for 200th Anniversary celebrations that the Strategic Planning Committee would support. The events could potentially include picnics (valley and state-wide), dinner theaters/dances, support for and representation at Grand Master's Day, close planning with the Grand Lodge for celebration of Freemasonry in general, "Lost Symbol" movie nights (pending release date), media contacts developed, and possible sale of polo/golf shirts with a state SR logo.

That the second in line officers from the Consistories (together with representatives from the two valleys from Lafayette not represented – either valley or consistory officers) be involved with this committee to be better able to coordinate their year as Commendars in Chief, Thrice Potent Masters etc. – with the idea that they should be planning their year somewhat like a blue lodge Master. Valley secretaries would also be invited to attend as consultants to share their expertise.

That in line with the previous recommendation, that there be a more formal "second in line" or assistant/shadow officers for Valley/Cconsistory sec-

retaries and treasurers, together with other officers that a Valley or Consistory deems necessary to be understudied. We all know that retirements, moving out of state, job changes, and even the fragility of life can cause potentially complicated times for a body. A formal officer understudy program should be in place to smooth any transition, and this would include shadowing the current officer as an assistant and attending Supreme Council conferences as necessary.

That the development of a state-wide communications committee be formed. Their duties would include the set up of a state-wide newsletter that would include degree dates as well as other program dates to facilitate communication and visitations. One aim would be also to provide a stronger presence in the Connecticut Freemason – possibly a double page spread with information and articles from all valleys (think of an expanded YR Opportunities presence). This could be in addition to the current Valley/Consistory newsletters which in the future could be incorporated into the state publication if deemed expedient. This committee would also investigate and utilize the use of the Internet through websites, and their upgrades, as well as use of social media, including Facebook for example, to increase the visibility of Connecticut Scottish Rite for our members, who are becoming more knowledgeable in this area. The committee would seek out our more tech-savvy members to assist in this and the upkeep of the websites/pages.

That the idea of Scottish Rite research/study groups be promoted at the Valley and state level – our Scottish Rite history and philosophy as well as the degrees and their history need to be brought to the attention of our members for the education and inspiration that they can provide. This could include book discussions, study groups, and the potential for a formal state level research society in the future.

The committee welcomes any and all feedback on these recommendations as we continue to forge a stronger and vibrant future for the Scottish Rite in Connecticut, and we would also like to thank out Illustrious Commander in Chief, officers and brethren of the Council of Deliberation for giving us the opportunity to participate in this very important process.

REPORT OF THE BOARD OF GOVERNORS OF THE CHILDREN'S DYSLEXIA CENTER OF CONNECTICUT

To the Illustrious Commander-in-Chief, officers, and brethren of the Connecticut Council of Deliberation in session at Ansonia, Connecticut on June 15, 2012:

Greetings from the Board of Governors.

In my 2009 report to this Council, I began my remarks by saying: "My Brothers all, what a difference a year makes! The devastation in the economic and investment communities has had a similar negative impact on the Benevolent Fund of the Scottish Rite in Lexington and has necessitated a significant change in the funding paradigm for the 32° Masonic Learning Centers for Children. Now, more than ever, the 32° Masonic Learning Center for Children in Waterbury is your center. It's doors will remain open only through the generosity of the Scottish Rite Valleys and individuals here in Connecticut." Other than a name change to "Children's Dyslexia Center of Connecticut — A Scottish Rite Masonic Charity," little else has changed. The doors of the Center remain open largely through the generosity of our Scottish Rite Valleys and individuals here in Connecticut and the Board of Governors thanks each of you and your Valleys for your continued support.

We continue to assist the maximum number of young people who can be accommodated by the existing center. For the fiscal year 2013 which begins on September 1, 2012, the Waterbury Center will again receive \$50,000 from the Benevolent Fund. The remainder of our \$117,000 budget must be raised by us locally.

Two major activities continue to dominate our fundraising endeavors, the 5K Road Race/Walk in Newington on Saturday, July 28 under the chairmanship of Brother Jeff Flynn and the Annual Walk for Dyslexia Awareness in Waterbury on Sunday, October 14 under III. brother Russell Griswold's continued direction. In conjunction with the Valley of New Haven, a wine tasting event has been scheduled for May 18, 2013 at the Whitney Avenue, New Haven Masonic Temple. Again, I urge each Brother here to become active in these important fundraisers — if not as an active runner, walker, or taster —then by gathering monetary and other donations in support of the effort. More information will be available as we approach the dates for these three events.

This report would not be complete without acknowledging the individuals who continue to give of their time and talents to make the Children's Dyslexia Center of Connecticut an ongoing success. Ill. David Sharkis, 33° volunteers untold hours throughout the year to make sure the physical needs of the Center's facility are met and to keep the Center in excellent repair. A. J. Kayser and Cheryl Sharkis continue to go well beyond what they are paid to do and are excellent ambassadors for Scottish Rite Masonry. REPORT OF THE DIRECTOR 32° MASONIC LEARNING CENTER FOR CHILDREN VALLEY OF WATERBURY

To the Illustrious Commander-in-Chief, officers, and brethren of the Connecticut Council of Deliberation in session at Ansonia, Connecticut on June 15, 2012:

Good afternoon and greetings from all of us at the Children's Dyslexia Center of Connecticut. I am Cheryl Sharkis, the Director, Trainer, and a Tutor at the Center.

We are proud to report to you that the Children's Dyslexia Center continues to develop and progress forward. We have celebrated the achievements of 85 youngsters. Upon completion of their work at the Center, all have progressed at least 2 to 3 grade levels in their reading skills, with many surpassing this average. The most current ceremony was June 5, with 12 youngsters completing their work at the Center. At present, we have experienced 9 Celebration of Achievement Ceremonies. Alumni continue to periodically stop by to share their achievements and upcoming plans. We are thrilled and moved that they are willing to take time out of their busy schedules and remember their Tutors. There is no feeling better than knowing that you have made a positive difference in a person's life!

The Center staff currently includes 8 Initial Level Tutors, 2 Advanced Level Tutors, and 1 Supervisor, with 3 additional Scholars submitting paperwork for certification this summer. In total, the Center's Scholar training program has certified 29 Tutors. The final touches are being made to an introductory contact letter to Post University in hopes of enticing an affiliation between the Center's Scholar Training Program and the University's graduate programs. Our next Scholar training cycle is scheduled to begin September 2. We are always on the lookout for a few good scholars, so if you or someone you know is interested, please contact the Center.

The Center is currently providing tutorial sessions to 22 youngsters. Once again, we are in the process of finalizing each youngster's annual progress assessment and we are thrilled to report that everyone is progressing and developing, with the gap between their grade levels and performance levels reducing significantly. There are approximately 19 youngsters remaining on the waitlist. If you know of a child that may benefit from participating in the Children's Dyslexia Center Program, please encourage their families to contact the Center.

We are all very proud to be participating in such a positive and empowering youth program. Enabling these youngsters to better achieve their academic potential is magnificently rewarding and uplifting for all involved. Individual generosity, the annual Run and Dyslexia Awareness Walk, and all the continued support from the supporting Masonic bodies perpetuates the rewards.

Thanks to the Scottish Rite philanthropic endeavors, you are enabling these youngsters to, as Katy Perry's "Firework" lyrics invoke, ignite the light and let it shine!

RULES AND REGULATIONS for the CONNECTICUT COUNCIL OF DELIBERATION ANCIENT ACCEPTED SCOTTISH RITE OF FREEMASONARY

<u>ARTICLE I</u> Title and Allegiance

Sec. 1 This Council shall be known as "Connecticut Council of Deliberation of the Ancient Accepted Scottish Rite of Freemasonry".

Sec. 2 It is formed under and hereby acknowledges and yields allegiance to the Supreme Council of Sovereign Grand Inspectors General of the Thirtythird and last degree of the Ancient Accepted Scottish Rite of Freemasory for the Northern Masonic Jurisdiction of the United States of America, having its Grand East in the City of Lexington, Massachusetts.

ARTICLE II

Meetings, Notices, Quorum

Sec. 1 The Connecticut Council of Deliberation shall meet annually. The time and place of each Annual Meeting shall be determined by the Council, provided, however, that such time and place of meeting may be changed by the Deputy for any reason deemed by him to require such action.

Sec. 2 A special meeting of this Council may be called by the Deputy for such time and place within this state as he shall determine, or by this Council at any annual meeting.

Sec. 3 Written or printed notice of each annual or special meeting of this Council shall be given by the Secretary, to be served either personally or by mail, to each member at least ten (10) days before said meeting. Such notice shall state the purpose thereof.

Sec. 4 Accredited representatives of a majority of the Scottish Rite Bodies in this state shall constitute a quorum for the transaction of business.

ARTICLE III

Members, Officers

Sec. 1 - The members of this Council of Deliberation shall be such as are prescribed by the Supreme Council.

Sec. 2a - The Council shall elect the following officers at each annual meeting to hold office for one year or until their successors shall be elected and installed:

First Lieutenant Commander Second Lieutenant Commander Minister of State Chancellor Prior Treasurer Secretary Hospitaler Master of Ceremonies Seneschal Standard Bearer Guard Sentinel

Sec. 2b - The Commander in Chief shall appoint a member of this Council of Deliberation as Grand Historian who shall keep a record of all events of historical significance and report thereon to this Council annually.

Sec. 3 - In case of vacancy in any office, by death, removal from the jurisdiction or otherwise, or failure to elect officers in this Council, the Illustrious Commander in Chief may make appointments to be in force until the next annual meeting.

Sec. 4 - Each officer of this Council shall perform the duties customarily incident to his office in accordance with Masonic usage and shall perform such other duties as may be assigned to him by resolution of this Council or by the Illustrious Commander in Chief.

Sec. 5 - The officers shall be installed at the annual meeting or as soon thereafter as practicable.

Sec. 6 - Scottish Rite Bodies in this State may elect members of the Rite in good standing in the Northern Jurisdiction as Honorary Members under such rules and regulations as their By-Laws may prescribe; provided, however, that no member of a Valley may be elected an Honorary member of the Valley in which he is a member.

Sec. 7 - Semi-public installation of the officers of Scottish Rite Bodies in this State is permitted.

Sec. 8 - A personal contact shall be made with each resident Connecticut member of the Scottish Rite before he can be suspended or dropped from membership for non-payment of dues and assessments. The Thrice Potent Master of each Valley shall be responsible for the personal contact in his Valley, and a report shall be made available to the Secretary of the Valley. The Secretary shall retain the report for future reference and the records.

Sec. 9a - This Council of Deliberation authorizes the holding of dual memberships for members of the Scottish Rite in the Northern Masonic Jurisdiction.

Sec. 9b A member of the Rite holding membership in a Valley outside of this state may apply for dual membership in a Valley in this state provided dual membership is permitted in the state of his membership, or a waiver of jurisdiction is obtained.

Sec. 9c A dual member shall be required to pay the customary dues of the bodies which he joins, but no fee becoming a dual member shall be charged

ARTICLE IV Standing Committees

Sec. 1 At the close of each annual meeting, the Illustrious Commander in Chief, or in his absence the presiding officer, shall appoint the following Standing Committees to continue in office until a new committee be appointed:

> Committee on Business Committee on Credentials Committee on Dispensations and Charters Committee on Finance Committee on Meritorious Service Award Committee on Necrology Committee on Necrology Committee on Next Place of Meeting Committee on Nominations Committee on Rules and Regulations Committee on State of the Rite Committee on Insurance

Sec. 2 The Committee on Business shall review the address of the Illustrious Commander in Chief and shall make recommendations regarding the apportionment and disposition of the several parts of the address.

Sec. 3 The Committee on Credentials shall pass on the qualifications of every person presenting himself for attendance at each annual or special meeting of this Council and to report thereon at such meeting.

Sec. 4 The Committee on Dispensations and Charters shall investigate every application for a dispensation or charter and make a written recommendations thereon to this Council.

Sec. 5 The Committee on Finance shall audit the books and accounts of the Secretary, Treasurer, and Hospitaler and make a written report thereon at the annual meeting of this Council. It shall prepare and present a budget of estimated receipts and expenditures for the ensuing year.

Sec. 6 "The Committee on Meritorious Service Award shall consist of the Presiding Officers of the Bodies of the Rite in the state, who shall present recommendations in writing through the Chairman of the Committee, to the Commander-in-Chief prior to each Council of Deliberation."

Sec. 7 - The Committee on Necrology shall report at each meeting of this Council the names, degrees, titles, and date of death, of all members of the Supreme Council in this state dying during the preceding year, together with similar data on such other outstanding Masonic leaders as it may deem proper. Sec. 8 - The Committee on Next Place of Meeting shall recommend at each annual meeting of this Council a place for subsequent annual meeting or meetings of this Council.

Sec. 9 - The Committee on Nominations shall consist of the members of the Supreme Council accredited to this state. It shall be the duty of such Committee to nominate candidate for election to the offices of this Council at each meeting place.

Sec. 10 - The Committee on Rules and Regulations shall consider all matters pertaining to the laws, rules, regulations, and jurisprudence referred to it by the Deputy or by this Council and shall make recommendations thereon.

Sec. 11 - The Committee on State of the Rite shall consider throughout the year all matters pertaining to the State of the Rite in this state, make recommendations to the Deputy from time to time, and it shall make a written report to this Council at each annual meeting.

Sec. 12 - The Committee on Insurance shall consist of three members who shall administer all insurance and related matters pertaining to the Scottish Rite Bodies in the state of Connecticut.

ARTICLE V Finances

Sec. I - The Secretary of each body of the Rite in this state shall, annually, at least seven days prior to the annual meeting forward to the Secretary of the Council of Deliberation a detailed statement of the proceeding year's work and a remittance of the per capita tax of one dollar (\$1.00) (as amended 8/15/2007) per each member on it roll of membership as of May 31.

Sec. 2 - This Council at any annual or special meeting may vote assessments on the Bodies of the Rite in this state as this Council shall deem proper, provided, however, that every such additional assessment shall be designated for some particular purpose and shall be used only for that purpose.

Sec. 3 - The fiscal year of this Council shall begin on the first day of August in each year and shall end on the 31st day of July in the next succeeding year.

Sec. 4 - No money shall be drawn on the Treasurer except upon a warrant signed by the Secretary, countersigned by the Illustrious Commander in Chief, and issued in payment of an appropriation or in accordance with an order previously made by this Council.

Sec. 5 - The Secretary, Treasurer, and Hospitaler of this Council of Deliberation shall be bonded in such manner and in such amount as shall be determined by resolution of the Council, or in default of such determination then determined by the Deputy, the premium on such bonds to be paid by this Council.

ARTICLE VI Jurisdiction of Valleys

Sec. 1 Each Valley in this state shall have concurrent jurisdiction within the State of Connecticut.

ARTICLE VII Meritorious Service Award

Sec. 1a : "An award be known as the 'Frederick H. Lorenson, 33°, Meritorious Service Award is hereby renamed for the State of Connecticut." It shall be conferred upon Scottish Rite Masons who, by reason of meritorious services of a Masonic character, are worthy and should be so cited.

Sec. 1b The award shall consist of a jewel in memory of the late Deputy for this state, Ill. Frederick H. Lorenson, 33°.

Sec. 1c The recipients must have received the grade of Sublime Prince of the Royal Secret.

Sec. 1d The awards in any one year shall not exceed the number of Valleys in the State, and nominations hereafter shall be so limited that no Valley shall have more than one holder of such award per seventy-five members in its Lodge of Perfection; provided, however, that if in any one year a Valley would be prevented by such limitation from having a member eligible to receive the award, the Presiding Officers of such Valley may present one nomination to the Council of Deliberation which may confer the award on the member so nominated, even though it exceeds the above limitation. Such number of awards may be reduced by the Council of Deliberation, but may not be increased. (N.B. Not to exceed Constitutional limitation on nominations in each Valley.) [ART. 904(d)]

Sec. 2 The following procedure shall be followed by this Council relative to selecting those who are to receive such awards and in presenting the awards to those selected.

Sec. 2a The presiding officers of the Bodies of the Rite in the state shall present recommendations in writing to the Council of Deliberation, nominating the member or members of their bodies whom they feel should receive the award. No presiding officer is eligible to receive this award while he is involved in the nominating process.

Sec. 2b Such nominations shall be referred to the Standing Committee on Meritorious Service Award at least one month prior to the annual meeting of this Council, except that by unanimous consent of this Council nominations may be referred to the Committee at the annual meeting for consideration at that annual meeting.

Sec. 2c The Committee on Meritorious Service Award shall consider the nominations referred to it from the various Valleys and shall make recommendations to this Council, at each annual meeting thereof, of members of the Rite in this State to receive the Meritorious Service Award.

Sec. 3 The presentation of the award and insignia shall be made by the Deputy, or someone selected by him. Such presentation shall be made either in

the Valley in which the recipeent is a member or at the meeting of the Council of Deliberation, as the Deputy may determine.

Sec. 4 - The jewel shall consist of an ornamented gold bar, one and a half inches long, with the words "Connecticut Council of Deliberation" in gold letters set in red enamel. A second gold bar, one and a quarter inches long, is suspended from the first bar by five gold links. On this bar shall be the words "Frederick H. Lorenson, 33°, Meritorious Service Award" in gold letters set in red enamel. A double headed eagle, emblem of the Thirty-Second Degree, is suspended from this second bar by three gold links. The figures "32" are of gold set in a triangle of black enamel. The height of the jewel shall be two and three-quarters inches.

ARTICLE VIII Amendments

Sec. 1 - By Amendment of Supreme Council Constitutions, etc. Upon amendment of the constitutions and regulations of the Supreme Council of Sovereign Grand Inspectors General of the Thirty-third and last degree of the Ancient Accepted Scottish Rite of Freemasonry for the Northern Masonic Jurisdiction of the United States of America, or upon the promulgation or any decree of said Supreme Council, inconsistent with any provision of these Rules and Regulations, then in every such event, and without any further act or deed whatsoever, these Rules and Regulations shall be deemed to be and shall be automatically amended in conformity therewith.

Sec. 2 - By Council of Deliberation, these Rules and Regulations may be amended at any annual meeting of this Council by a majority vote of the members present, provided the proposed amendment or amendments have been presented at the proceeding annual meeting, and due notice thereof shall have been given to the members and provided, further, that an amendment or amendments may be adopted at the annual meeting at which it is presented, by a two-thirds vote of the members present, thirty (30) days notice of the proposed amendment or amendments having been given to the members.

Sec. 3 - All By-Laws, Rules and Regulations previously adopted by this Council are hereby rescinded.
